Chief Hollow's life story was typical of so many of his generation who were born amidst the era of the Great Depression and who as children witnessed the sadness that engulfed the families who lost loved ones in World

They did not take life for

granted and pursued the American Dream to its utmost, while at the same time devoting their lives to their families and communities.

Chief Hollow began his career in public service in 1966 as a reserve police officer and eventually became a full-time officer in 1969.

Chief Hollow's hard work and dedication both to the Lynn Police Dept. and its citizenry resulted in his steady progression

#### St. Mary's Queliz receives offers from Division 1 college basketball programs

St. Mary's junior Yirsy Queliz is everything you would want in an elite point guard: she can run the break, shoot the three, drive the lane, distribute the basketball, and play the tough defense.

Queliz showed just how great she can be in the Spartans' 59-37 victory over Pentucket in the season opener Friday night. Queliz scored 21 points and had 11 assists as St. Mary's defeated a perennial Division 2 powerhouse on the road in front of a large crowd

Women's college basketball programs are taking notice of Queliz's talents. In fact, two Division 1 college basketball programs - Northeastern in Boston and Sacred Heart in Connecticut - have offered her scholarships. Other schools have Yirsy Queliz on their list of potential recruits.

St. Mary's head coach Jeffrey Newhall said the fact that his 5-foot-3-inch star is garnering big-time attention is not a surprise.

"Yirsy is obviously a gifted basketball player and I'm glad that she's being noticed by pro-

#### 'TIS THE SEASON FOR GIVING -- AND NEVER HAS THE NEED BEEN MORE URGENT

"It was the best of times; it was the worst of times." -- Charles Dickens, A Tale of Two

With Christmas fast approaching, most of us will be rushing about -- either to the stores and malls or on-line --- to do our holiday shopping in hopes of finding that "perfect" gift for our family members and loved ones.

Despite the pandemic that has ravaged our nation in so many ways, most Americans actually are doing okay, if not extremely well. Sure, the pandemic has made life inconvenient and not as enjoyable as usual for everybody, but most of us are getting along just fine.

Those who are able to work from home have not suffered a loss of income. And for those among us who have any sort of investments, from real estate to the stock market to certain types of small businesses, the pandemic has been a boon.

However, the good economic news for the majority of Americans has not been shared by all. For a sizable minority of our fellow citizens, the effects of the pandemic represent an existential

Millions of Americans of all ages, in a percentage greater than at any time since the Great Depression, are struggling financially.

To put it in stark terms, more Americans, including families in our own communities, are going hungry than at any time in our history.

Far too many of our fellow citizens, including children, live either in shelters or in similar temporary housing arrangements -- or on the streets -- because the reality of our economy has left them out in the cold -- literally -- thanks to the pandemic.

The homeless always have been among us, but the scope and depth of the problem is far beyond anything that has been experienced in our lifetime. The vast discrepancy between the enormous wealth enjoyed by some Americans and the abject poverty being endured by others is similar to what has existed in major urban centers in South America and India -- but it now is happening right here in the U.S.A.

For these millions of Americans, the holiday season brings no joy.

Psychologists tell us that the Biblical directive, that we should give to those who are less fortunate, actually is the best gift that we can give to ourselves. Helping others activates regions of the brain associated with pleasure, social connection, and trust, creating the so-called "warm glow" effect.

Never in the lifetime of anybody reading this editorial has the need for donations to local food banks been more urgent. There will be ample opportunity to do so in the coming days to make the holidays brighter for those who are less fortunate -- and there is no excuse for failing

#### **GOP'S OPPOSITION TO** RACHAEL ROLLINS

The unprecedented opposition, accompanied by unprecedented vitriol, by the Republican members of the U.S. Senate to the nomination of Suffolk County District Atty. Rachael Rollins for the position of U.S. Attorney for the Massachusetts district has laid bare their driven agenda.

Here is what Tom Cotton, the odious Arkansas Senator, said during a hearing of the Senate Judiciary Committee in opposing Ms. Rollins's nomination:

"Miss Rollins appears to measure success as a prosecutor not by how many victims and innocent people she protects, but rather by how many criminals she keeps from facing consequences. If she's confirmed as the US attorney, the cartels and the gangs that are fueling violence and death in our communities will be gleeful. Rachael Rollins wants to destroy the criminal justice system from within. That's not hyperbole."

Cotton's last line -- "That's not hyperbole" -- ordinarily would be laughable, but unfortunately it is illustrative of the way that leading GOP politicians are gaslighting the country these days to appeal to the basest of their base.

Senator Cotton's sham statement also has put on full display the propensity among leading GOP politicians to bully women, and that is doubly so for women of color. We recall the vote by Mitch McConnell and the GOP-controlled Senate in 2017 that silenced Senator Elizabeth Warren during the confirmation hearing for Jeff Sessions as U.S. Attorney General when she read a letter (which already was part of the Congressional Record) by Coretta Scott King in 1986 about Sessions. Later, a male senator read the same letter -- but without a peep from McConnell.

These GOP politicians are like the "tough" guys who have no hesitancy to engage in roadrage behavior when the other driver is a woman, but they shrink from honking, gesticulating, etc. if the other driver is a male.

Rachael Rollins had the full support of both of our U.S. Senators, Ed Markey and Ms. Warren, as well as the endorsement of many others, including former governor William Weld (who served as the U.S. Attorney in Mass. in the 1980s), Wayne Budd (another former U.S. Attorney here), Winthrop Police Chief Terence Delehanty, and Revere Police Chief David Callahan (both of whom work directly with the Suffolk D.A.'s office on a daily basis).

Despite the roadblocks thrown up by the GOP senators, the nomination of Rachael Rollins finally was approved, though only because of a tie-breaking vote by vice-president Kamala

We wish to congratulate Ms. Rollins upon her confirmation and we look forward to her tenure as our U.S. Attorney for the Massachusetts district.

#### Somehow, some way, may this be a Christmas worth remembering

We had difficulties when we were growing up in Martin county, Kentucky but overall, we thought we were doing okay. President Lyndon Johnson came to Inez, Kentucky in 1964 to let us know we weren't doing very well. He began his campaign in our community and we became the poster child for American poverty. We hadn't really thought of ourselves as poor until we started hearing about ourselves in the news.

I had numerous friends who didn't get much for Christmas. Often it was one or two small gifts or nothing at all.

Several classmates at my elementary school in Tomahawk, Kentucky were fortunate if they had a coat to wear in the winter. Ragged looking shoes on a kid's feet during the winter was a common sight.

Several classmates came to school to wash their faces and hands in the boys' bathroom. The school lunch was the only decent meal some of the kids ate during the week.

It was a while before President Johnson's 1964 promises started helping our area. Even with the roll out of government assistance many families subsisted until the coal boom of the seventies which has almost died. Today our county is reinventing itself with agriculture, a service center to aid bitcoin mining, tourism and small businesses.

I don't remember every Christmas, but I remember one. My dad broke his back falling off a barn when I was a child. He was out of work for several months and in those days, we didn't have government safety nets to see us through tough financial times. Christmas came as usual and we did put up a tree. Our family gathered on Christmas Eve and we had food, fellowship and laughter. We always raised a garden and my parents stored food so it came in handy during tough times.

I expected nothing for Christmas that year because the heaviness of family financial pressure was obvious even as a child. Surprisingly, my mother handed me a small wrapped box that Christmas Eve and said Merry Christmas. I was shocked because I expected nothing that year. Opening the box, I found a watch that had numbers that glowed in the dark. It may have cost \$5 but it was priceless to me. I was thrilled and wore it every night to just look at the glowing numbers.

Dad was recuperating that Christmas. His temporary disability and our financial stress made life gloomy for us that year. Yet, here I am remembering that Christmas as one of the best of all. It was during that Christmas that I remember the presence of family. Mom and dad were alive. We had food to eat. We had a roof over our heads and our family had each other.

This may not be your best Christmas, but maybe, just maybe you can still have Christmas.

The empty chair is painful. Depression is real. Financial or other personal

## Lynn man sentenced to 15 years in prison

A Lynn man was sentenced in federal court in Boston for conspiring to distribute methamphetamine and possessing firearms.

David Oth, a/k/a "Baby Bouncer," a/k/a "BB," 32, was sentenced today by U.S. Senior District Court Judge Mark L. Wolf to 15 years in prison and six years of supervised release. On Aug. 5, 2021, Oth pleaded guilty to conspiracy to distribute and possession with intent to distribute 50 grams or more of methamphetamine and possession of firearms in furtherance of a drug trafficking crime.

Oth was a member of the Tiny Rascals Gangsters, a violent street gang with a presence in Lynn, Malden, Salem and Lowell. Oth and other gang members conspired for over a year to distribute methamphetamine and other drugs by transporting them to Maine, where they would yield a higher resale value. A search of Oth's residence in February 2021 resulted in the seizure of approximately three pounds of 100% pure methamphetamine and two firearms.

Acting United States Attorney Nathaniel R. Mendell; Joseph R. Bonavolonta, Special Agent in Charge of the Federal Bureau of Investigation, Boston Division; James Ferguson, Special Agent in Charge of the Bureau of Alcohol, Tobacco, Firearms & Explosives, Boston Field Division; Colonel Christopher Mason, Superintendent of the Massachusetts State Police; and Lynn Police Chief Christopher P. Reddy made the announcement. Assistance was provided by the U.S. Attorney's Office for the District of Maine; Maine Drug Enforcement Agency; Essex County, Middlesex County and Suffolk County District Attorney's Offices; Essex County and the Hancock County (Maine) Sheriff's Departments; and the Malden, Salem, Bangor (Maine), Portland (Maine) and Westbrook (Maine) Police Departments. Assistant U.S. Attorneys Philip A. Mallard and Sarah Hoefle of Mendell's Organized Crime and Gang Unit prosecuted the case.

This effort is part of an Organized Crime Drug Enforcement Task Forces (OCDETF) operation. OCDETF identifies, disrupts, and dismantles the highest-level criminal organizations that threaten the United States using a prosecutor-led, intelligence-driven, multi-agency approach. #### Lynn English Drama Club to present play by Simon Stephens

The English Theater Collective, the drama club at Lynn English High School, is tackling an important work for their first show of the 2021-22 school year. "The Curious Incident of the Dog in the Night-Time" is a play by Simon Stephens based on the book of the same name by Mark Haddon. It is the story of fifteenyear-old Christopher Boone, who has decided to investigate the killing of a neighbor's dog. In the process he discovers that the crime comes closer to home than the neighbor's house and his investigation sends him on a journey of which no one would have believed he was capable. Christopher is not just a curious teen. He is also autistic. Haddon's groundbreaking book, told from Christpher's point of view, was turned into an award-winning play. The story not only helps the audience understand how some autistic people experience the world, but it exemplifies the humanity of disabled people/youth and lets us see what people are capable of, given the drive and the support of a good teacher.

Young Christopher Boone has an unspecified form of autism and attends a special school. He loves math and astronomy and science and excels in genius levels at them. But he is overwhelmed by the sensory input of the outside world. He cannot stand to be touched and when too much is happening around him, he shuts down completely. His teacher Siobhan has given him some strategies to cope, like counting the prime numbers. When he discovers that a neighbor's dog has been killed with a garden fork, he decides to indulge his love of mysteries and Sherlock Holmes and try to solve the murder. His mother has died and his father, a rough but loving man, tries to discourage Christopher from poking his nose into other people's business. But as he investigates he makes discovery after discovery that lead him eventually to take a trip into the chaotic outside world, from his town of Swindon eighty miles to the bustling city of London.

The students at LEHS have decided to take on this challenging work as part of their anti-racist/anti-discrimination manifesto implemented last year. The organization has made a pledge to

not only ensure that the members of the club reflect the impressive diversity of their school, but to present stories of underrepresented populations. The students see the stage as a platform for social and racial justice and want to give voice to the voiceless. This is the most challenging piece the students have ever worked on, incorporating more technical elements and technology than we have ever used before. With a cast of thirteen with many actors playing several roles and a lead actor who appears in every scene, the challenges are great. But the students are rising to the challenge, exhibiting dedication, determination, and emotional sensitivity...much the way Christopher does.



#### HOLIDAY GATHERING FOR WARD 7 COUNCILOR JAY WALSH




(one-half) scrimmages. Following are his responses:

#### WYNN DEVELOPMENT PROPOSES ENTERTAINMENT COMPLEX

of Everett," said Everett Mayor Carlo DeMaria. "The addition of the pedestrian bridge as part of the proposed plan will increase safety for Everett residents and all pedestrians and will serve as a gateway to a revitalized Lower Broadway District and a new future for Everett."

The site for the proposed development is located on land purchased by Wynn Development along the east side of Broadway between Dexter and Mystic Streets and will be in the Lower Broadway Economic Development District. The project will contribute to transforming the district from an industrial area into a mixed-use neighborhood that supports access to the waterfront. In addition, a generously landscaped sidewalk protected by street trees will both improve the pedestrian experience and accommodate changes for the future implementation of Broadway Complete Streets.

Traffic Study for East Broadway Development

Improving public safety along Lower Broadway

- The proposed bridge would meet the needs of pedestrians by being open 24-hours and having elevator access, moving walkways (like those in airports), and being enclosed with heating and cooling. The bridge would be

monitored for safety, maintained, and decorated by Wynn Development.

Enhancing Traffic Flow on Broadway and Adjacent Roads

- The proposed pedestrian bridge will significantly enhance the traffic flow on Broadway by removing the need for the long-cycle crosswalk and light signals and the time waiting for pedestrians to cross that can cause backups.
- The AECOM traffic study commissioned by Wynn Development shows that the proposed pedestrian bridge will not only mitigate any increased traffic generated in the future by the proposed entertainment venue and restaurant, it will also improve the current rate of traffic flow and reduce traffic in adjacent intersections by increasing their car capacity ability by 29%.
- The proposed bridge and elimination of the crosswalk signal and people crossing would mitigate traffic flow issues created by the entertainment venue and restaurants. The AECOM traffic study projects the following changes to Broadway traffic during commute times:
- o Morning commute 7-9 am: range from 15 -22 additional cars
- o Evening commute 5-6 pm 120 additional cars
- Additionally, Wynn Development is proposing adding new turning lanes on Broadway and on Dexter Street that would serve the proposed parking garage, which would move cars generated by the restaurant or entertainment venue out of the traffic flowing on Broadway.

Enriching the Streetscape of Lower Broadway

- The proposed pedestrian bridge, designed by Elkus Manfredi, will be a beautiful and highly functional part of the streetscape of Lower Broadway with its access points being welcoming and attractive parts of the sidewalks and contribute to the City of Everett's current efforts to making the city more pedestrian-friendly.
- Wynn Development is proposing generous landscaping and attractive hardscaping at the development site that will make Lower Broadway a more inviting, exciting, and beautiful public space for residents of Everett and visitors.
- Wynn Development is also proposing the widening of Dexter Street (off Broadway) which will improve both the appearance and traffic flow on that street.


