## **Juneteenth** kicks off with flag raising at City Hall

Juneteenth has received universal attention since becoming a federal holiday last year and the North Shore Juneteenth Association in Lynn (NSJA) kicked off the holiday with their annual flag raising ceremony at Lynn City Hall Tuesday.

Tuesday's flag raising, and others planned for neighboring North Shore communities, will culminate in the NSJA's annual Juneteenth Celebration at Lynn Museum on Sunday, June 19.

The Juneteenth holiday commemorates the ending of slavery in the U. S. Celebrating the holiday on June 19 gives the community a chance to learn about the positive contributions African Americans have made to society.

NSJA President Nicole Mc-Clain said a fun filled day is planned at the Lynn Museum, with an added celebration honoring fathers on Fathers Day.

Like year's past NSJA's celebration will include music, live performance, spoken word poetry, soul food and dance from 11 am to 5 pm at the Lynn Museum.

"There is obviously more attention on Juneteenth after it became a federal holiday," said McClain. "Our organization has become more well known and more significant on the North Shore than when we first began. We have all these North Shore communities reaching out to



career in sports broadcasting. Hoffman is retiring as the play-by-play announcer for Everett High School football, but he will be continuing his work with Lynn TV-15 sports.





## EDITORIAL

### **EXASPERATED BY HIGH ENERGY COSTS?** WAIT UNTIL THIS WINTER

Barely a day goes by without a news story about the high cost of gasoline and energy prices in general.

Economists and energy market experts point to a host of reasons as to why the market prices for oil and natural gas have skyrocketed in the past three months. The war in Ukraine only exacerbated what in any event would have been a world-wide energy crisis thanks to the decision by the OPEC+ nations and U.S. oil companies to limit output -- in order to reap huge profits for their shareholders -- despite increased world-wide demand in the aftermath of the pandemic.

However, whatever the reasons may be, they are of little consolation to Americans who must drive a car every day and who face record-high prices of more than \$5.00 per gallon for regular gasoline.

It often is said by economists that higher energy prices effectively are a tax on consumers. But higher energy costs are even worse than a tax. We're paying higher gasoline prices for the exact same product, but with higher taxes, at least in theory we'd be getting more services for our tax dollars.

The only ones directly benefiting from higher energy prices are the shareholders of the major oil companies and the dictators in places like Saudi Arabia and Russia.

But as painful as higher energy costs are right now, the real crunch will come this winter, when Americans in the northern half of the country will face costs for heating oil and natural gas that never have been seen. We paid \$3.00 for a gallon of heating oil this past winter -- but the price right now from our heating oil dealer is nearly \$6.00. At that price, a delivery of heating oil of 175 gallons -- about 2/3 of a tank -- will be more than \$1000, a figure that truly will be a hardship for many of us.

So let's start praying now for a mild winter -- and get used to the idea of taking shorter hot showers, dropping the thermostats in our homes, wearing sweaters during the day, using extra blankets at night, and sealing up the drafts through our doors and windows.

## Protecting our children from the shooters

Most federal career politicians end up very wealthy. They make good salaries. They have great health insurance and very nice retirement packages. They typically develop political action committees that cover expenses the government doesn't pay. When they retire, they can donate campaign funds they have accumulated throughout the years to their own non- profits and administer the funds.

Most Americans know how lucrative a lifetime of "public service" can become and few really care. Most of us have more to worry about than the jet setting life styles of our rich and famous U.S. Senators and Representatives. What torches many of us is their inability and often refusal to do anything. Too many of them are spineless wimps who are terrified of casting a vote that might hinder their reelection.

You've probably noticed that most and often all of the Republicans vote the "party line" and all the Democrats do the same. How does this help us?

I'm tired of the red vs the blue and vice-versa. Doesn't anybody

have an opinion that differs from their grand ol' party?

It's obvious that Americans are torn into shreds over the gun issue. There is no perfect answer. However, doing nothing isn't working to save the next group of children begging for help in

Establishing a six-month waiting period to buy an assault style weapon will not hurt anyone. All schools must pay for a couple of armed guards to patrol and protect their students. Even then a surprise attack by two or three people with assault style weapons and body armor could easily overpower guards carrying semi-automatic weapons. Yet, the presence of armed security is better than leaving our children defenseless.

One local county I know fairly well has several schools spread out over the county. They have one sheriff and he has two underpaid deputies. By the time he and the deputies could ever possibly even show up, dozens if not a multitude of children would be dead. This sheriff's department is very underfunded and would have to wait for state police to arrive. The local state police post is one hour away. It is unimaginable how many children could be killed. Such school systems have no choice but to come up with armed security guards to protect the children.

Who ever dreamed you would read something like this in your local paper? I never dreamed of a country where it would need to be written.

#### WE NEED YOUR HELP AND SUPPORT

To the Editor,

Portal To Hope (PTH), the award-winning nonprofit organization serving domestic violence crime victims in Everett, Lynn, Medford, Malden, Winthrop and neighboring Massachusetts communities, is facing a 27% budget cut effective July 1. Already operating as a small-funded nonprofit, PTH relies on \$179,900 in federal funding from the Victims of Crime Act (VOCA) to serve an average of 900 people each year.

Drastic cuts to will leave PTH to operate on 131,490 in fiscal year 2023 - asevere reduction. Considering that PTH spends less than 5% on administrative costs where volunteers time to carry-out administrative functions in order to dedicate funds for direct care service programs, the 27% budget cut will strap the organization and eliminate its Emergency Shelter program. "In talking with the public, they are as perplexed as we are as to why government keeps cutting funding to agencies serving some of our most vulnerable community members - especially when they realize all the helpful services that we provide," said Linda Morris, a survivor who has been sharing her time as a Victim Advocate at PTH for seventeen years. "As a survivor whose own life was impacted by a family member killed by her abuser, I struggle to understand why PTH and similar agencies are forced to beg for funding every year," said Morris.

VOCA funding is administered by the Massachusetts Office for Victim Assistance (MOVA); and MOVA announced that 124 programs and 220 victim services jobs across the Commonwealth are impacted by the drastic cuts to VOCA funds. "A state investment is critically needed to sustain and stabilize victim services across the Commonwealth to continue supporting victims and survivors," announced MOVA.

PTH's Founder, Deborah Fallon, a survivor of violent crime, is appreciative of the work that MOVA and the Victim and Witness Assistance Board (VWAB), which is chaired by Attorney General Maura Healey, are



us and wanting to collaborate on flag raising ceremonies and other events. I think that speaks volumes for the organization itself. ## Drunk driver charged in MV homicide

A Lynn man was arraigned today on motor vehicle homicide and other charges after he was charged with fatally striking a pedestrian and fleeing the scene, District Attorney Kevin Hayden

Miguel Rodriguez, 35, was arraigned today in the Charlestown Division of the Boston Municipal Court on charges of operating under the influence of alcohol, motor vehicle homicide by OUI alcohol and leaving the scene of a crash causing personal injury or death in connection with the crash in the early hours of Saturday, June 4, that claimed the life of 22-year-old Brandon Jennings of Marlboro. Rodriguez was released on \$5,000 bail, which he had previously posted after his arrest Saturday. He was additionally ordered to remain drug- and alcohol-free while the case is pending and not to drive without a valid license.

Assistant District Attorney Alexandra Rahimi of the DA's Major Felony Bureau told the court that Jennings accompanied friends and relatives to a bar in the area of the TD Garden on Friday. At some point during the night, he split from the group. He was later observed walking on Storrow Drive.

Shortly after 1:00 a.m. Saturday, a gray Honda Accord struck Jennings and fled. Another vehicle followed the car involved in the crash to an address on Centre Street in Lynn and provided the vehicle's license plate and location information to Massachusetts State Police.

State Responding Police Troopers arrived at the address and located Rodriguez in the parking lot. The key to the Accord was in his pocket. A portable breath test registered a blood alcohol level of .119 approximately two hours after the crash.

"I'm grateful to the individual who witnessed this crash and took quick action to provide police with information that led to an arrest in this terrible case. This helped provide Mr. Jennings' family with answers to questions about their loved one's death, and it ensures that my office is able to hold accountable the person responsible for taking his life," Hayden said.

Rodriguez returns to court August 18, 2022.

All charged individuals are presumed innocent until and unless proven guilty beyond a reasonable doubt.

doing in partnership with the Massachusetts Legislature to bridge the funding gap via the "VOCA Bridge Act". "MOVA and VWAB have been outstanding partners in our work serving people impacted by violent crime," said Fallon. "Every person has the right to live free from abuse, and while PTH and like programs are already inundated and focused-in on providing direct care services to people, we look to MOVA, VWAB and our legislators as our advocates in helping us to remain fully fund-

MOVA announced that the Massachusetts Legislature named a Conference Committee to "reconcile differences between the House and Senate final budgets". Conference Committee members are: Representatives Michlewitz, Ferrante, and Smola and Senators Rodrigues, Friedman, O'Connor. MOVA continues to advocate for a fully-funded VOCA Bridge

to sustain services for victims and survivors and is "requesting that the Conference Committee maintain the \$20M investment included in the House budget to bridge one-year of impending cuts" to VOCA funded programs for fiscal year 2023.
